2012 Audition Application

(Please read the application instructions carefully.)

Music Under New York (MUNY) is one of many visual and performing arts programs administered by Metropolitan Transportation Authority (MTA) Arts for Transit. Once a year, MUNY holds auditions to add new performers to its roster. Applications will be reviewed and approximately 60 eligible performers will be selected and contacted to participate in live auditions, held for one day.

During the auditions, a panel of musicians, music industry professionals, MTA representatives, community arts organizations members and others will judge each five minute performance on the criteria of quality, variety, and appropriateness for the mass transit environment including number of performers, space requirements, instruments, professionalism and volume.

MUNY performers are not paid (except for special events), but are allowed to accept donations from the public. As a MUNY member, performers call in or “book” their own performances every two weeks.

Audition Application Package Deadline: Postmarked by March 19, 2012

Application package should include:

- CD or DVD of you or your group (tape, video and other formats **NOT** accepted). Media does not have to be produced professionally, however please submit quality recordings that represent your talents.
- Completed Audition Application Form.
- *Optional material* includes any material that you would like to share including reviews, bios, etc.

PLEASE NOTE:

- **MATERIALS WILL NOT BE RETURNED.**
- Your audition performance **MUST** be the same as your subway performance with respect to group size and volume.
- Subway performers must abide by all rules and regulations as posted on the MTA website, www.mta.info/nyct/rules/index.html . Please read the rules carefully before auditioning.
