NOTICE TO VENDORS

Vendors interested in bidding opportunities listed on the Construction and Architectural/Engineering Opportunities page must adhere to the following requirements:

Central Contractor Registration (CCR)

Vendors must register with Central Contractor Registration (CCR), a federal vendor database used to validate vendor information, before obtaining construction and architectural/engineering bid documents. The registration process requires a DUNS number and can be done online at www.ccr.gov. It takes approximately ten minutes to register and you should receive a response within 48 hours. This process is free of charge.

DUNS and EIN

Vendors must provide their Data Universal Numbering System (DUNS) number and company Employer Identification Number (EIN) when ordering bid documents. The DUNS number is a unique nine-character identification number provided by the commercial company Dun & Bradstreet (D&B). Vendors who do not have a DUNS number may call D&B at (866) 705-5711 or (610) 882-7000, or visit D&B's website at www.dnb.com/us/ to obtain one. The website process to request a DUNS number takes about 10 minutes and is free of charge if you state you require the DUNS number for registration in the Central Contractor Registration website.

FedBizOpps Website

Vendors must register with FedBizOpps, www.fbo.gov, before obtaining construction and architectural/engineering bid documents. FedBizOpps, a federal website used to distribute and disseminate sensitive but unclassified procurement related materials, only accepts CCR registered vendors.

Vendors must download addenda documents from FedBizOpps. Vendors who have purchased bid documents will no longer receive addenda documents by mail, Instead, those vendors will be notified by email instructing to download it from FedBizOpps.

NYCT Prime Contractor & D/M/WBE Sub-Contractor Connection System

The MTA - New York City Transit (NYCT) Sub-Contractor Connection web-based initiative, created to connect potential prime contractors with D/M/WBE firms interested in NYCT sub-contracting opportunities has evolved to become the NYCT Prime Contractor & DMWBE Sub-Contractor Connection System (Sub-Contractor Connection System). Unlike the initial phase of this initiative, the Sub-Contractor Connection System will now notify plan holders (potential prime contractors) electronically when a D/M/WBE firm has expressed sub-contracting interest in a NYCT project. The system's ability to sort D/M/WBE firms by the service they provide also gives prime contractors a 24 hour detailed resource for qualified D/M/WBE firms.

D/M/WBE firms and prime contractors must be registered on the NYCT bidder list to access this system. Visit the NYCT Procurement Website to register on-line.
