Q1 2020: Planned Commitments \$1 B

- Signal modernization on Eighth Avenue Line
- Penn Station-33 St Corridor, Phase 1
- ADA accessibility at Livonia Av / Canarsie
- Metro-North Harlem River Lift Bridge



Q2 2020: Planned Commitments \$2.5 B

- Penn Station-33rd Street Corridor, Phase 2
- ADA accessibility at 4 stations in the Bronx
 - Westchester Square / Pelham
 - 149 Street Grand Concourse Complex (two-station)
 - Tremont Av / Concourse
- Elevator and escalator improvements at 11 stations
- Infrastructure repairs on the 2/3/4/5 line in Brooklyn
- New Elmont station
- New rolling stock
 - LIRR train cars and service locomotives
 - Work hybrid locomotives for NYCT
- Harold Interlocking Catenary



Q3 2020: Planned Commitments \$1.7 B

- ADA accessibility at 6 stations:
 - 14th Street & 6th-7th Avenues Complex (three stations)
 - 8 Avenue / Sea Beach (southbound)
 - Woodhaven Boulevard / Jamaica
 - Queensboro Plaza
- Structural repairs on the Flushing (7) Line, including renewals at 7 stations
- Sandy Repairs: Rutgers Tube (F) rehabilitation
- LIRR signal modernization, Babylon to Patchogue
- Four station renewals on Jamaica Line (J/Z)



Q4 2020: Planned Commitments \$1.3 B

- Penn Station Access
- ADA accessibility at 3 stations
 - 68 St-Hunter College / Lexington Av
 - Bay Ridge-95 St / 4 Av
 - Court Sq / Crosstown
- New substation at Canal St / 8 Av
- Second Avenue Subway Phase II (initial commitment)
- 45 new electric buses and electrification of 6 bus depots
- Sandy resiliency at West Side Yard and East River Tunnel
