This Notice of Examination was amended on September 22, 2021 to add a qualifying climbing assessment to "The Test" section.

#### JOB DESCRIPTION

**Structure Maintainers - Group C,** under supervision, perform ironwork on subway, surface and elevated structures, including stations, enclosures and related buildings; perform other structural work as necessary including incidental painting; perform shoring, welding, burning, rigging, high-strength bolting and rivet removal on steel columns, girders, stairways, gratings and station controls; perform electric welding, brazing, acetylene cutting, and sheet metal work on bodies of multiple-unit railcars, including repair and alteration of framing, sheeting and other railcar body components; load, unload and drive trucks and vans; and perform related work.

## JOB DESCRIPTION (Continued)

Some of the physical activities performed by Structure Maintainers - Group C and environmental conditions they experience are: working on or near tracks where live high-voltage equipment is present, climbing and descending ladders, working on elevated structures at heights of up to 160 feet and in confined spaces, working on suspended scaffolding, reaching into dark spaces and making tactile inspections, walking along trackways and catwalks in dimly lit areas, hearing and responding to warning whistles and sounds of oncoming trains, crawling under subway cars in maintenance pits, working outdoors in all weather conditions, and operating heavy machinery.

**Special Working Conditions:** Structure Maintainers - Group C may be required to work various shifts including nights, Saturdays, Sundays and holidays.

(This brief description does not include all of the duties of this position.)

## **SALARY AND BENEFITS**

The current minimum salary for Structure Maintainer - Group C is \$32. 93 per hour for a 40-hour work week increasing to \$38.75 per hour in the sixth year of service. This rate is subject to change. The benefits of this position include, but are not limited to, night and weekend salary differentials, paid holidays, vacation and sick leave, a comprehensive medical plan and a pension plan.

## **HOW TO QUALIFY**

**Education and Experience Requirements:** By the **last day of the Application Period**, you must meet the following requirements:

- 1. Three years of satisfactory full-time experience as a journey-level ironworker (i.e. fully trained, proficient, knowledgeable, experienced, and competent in performing ironwork); or
- 2. Completion of a four-year, full-time apprenticeship in the ironwork trade conducted or sponsored by a recognized trade union or recognized industry association or group.

For the journey-level experience in "1" above to be credited, **it must be preceded by** one of the following:

- a. Two years of satisfactory full-time experience as a helper or trainee performing or assisting in the work described above; or
- b. Graduation from a vocational high school with a major course of study in ironwork or a closely related field; or
- c. Graduation from a trade school or technical school with a major course of study in ironwork, or a closely related field, totaling 600 hours; or
- d. An associate degree or higher in ironwork or a closely related field.

If you have qualifying part-time experience, it will be credited on a prorated basis.

Experience which involves only incidental or occasional ironwork, such as mixed construction work, masonry, carpentry, auto body repair work, sheet metal work, or welding is <u>not</u> acceptable.

The vocational high school, technical school, or trade school must be approved by a State's Department of Education or a recognized accrediting organization. The college or university must be accredited by regional, national, professional or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education, and by the Council for Higher Education Accreditation (CHEA).

## **HOW TO QUALIFY** (Continued)

Foreign Education Fact Sheet (required only if you need credit for your foreign education for this examination): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation, as well as instructions on how to submit this evaluation are listed in the Foreign Education Fact Sheet, which will be attached to this Notice of Examination during the application period. When you contact the evaluation service, ask for a "document-by-document" (general) evaluation of your foreign education. Your foreign education evaluation must be submitted directly to NYC Transit's Examinations Unit by the service completing the evaluation. Foreign education evaluations received directly from applicants will not be accepted. You may also visit http://web.mta.info/nyct/hr/forms\_instructions.htm to access the Foreign Education Fact Sheet on our website.

**Note:** If you have earned a higher-level degree in the United States that supersedes the level and type of education required to meet the qualification requirements, you do not need to submit a foreign education evaluation. However, you must indicate that you have completed the higher-level degree in the United States; proof of acceptance into an academic program or school is not sufficient to determine satisfactory equivalency.

You are responsible for determining whether you meet the qualification requirements for this examination prior to applying. You may be given the test before we determine if you meet the qualification requirements. If you are marked "Not Qualified," your application fee will **not** be refunded, and you will **not** receive a score.

## REQUIREMENTS TO BE APPOINTED

**Driver License Requirement:** At the time of appointment, you must have a Motor Vehicle Driver License valid in the State of New York with no disqualifying restrictions that would preclude the performance of the duties of this title. If you have serious moving violations, a license suspension or an accident record you may be disqualified. This license must be maintained for the duration of your employment in the title.

**Medical Requirement:** Medical guidelines have been established for the position of Structure Maintainer – Group C. You will be examined to determine whether you can perform the essential functions of the position. Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable him or her to perform the essential functions of the job.

**Drug Screening Requirement:** You must pass a drug screening in order to be appointed, and if appointed, you will be subject to random drug and alcohol tests for the duration of your employment. Additionally, if you have tested positive on a drug or alcohol test or had a refusal to test during preemployment or while employed by a Federal DOT-regulated employer during the applicable period, you must have completed the Substance Abuse Professional (SAP) evaluation, referral and education/treatment process required by federal law in order to be promoted to this safety-sensitive position.

**Residency:** New York City residency is not required for this position.

**English Requirement:** You must be able to understand and be understood in English to perform the duties and responsibilities of the position.

**Proof of Identity:** Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with MTA New York City Transit.

#### HOW TO SUBMIT AN APPLICATION

You must submit an application during the application period, and applications will <u>not</u> be accepted in person. Applicants who apply online and wish to request a Fee Waiver <u>must</u> only complete the Online Applications Steps 1 through 4 below.

## **Online Applications:**

For best results when applying, please use the latest version of Internet Explorer, open a new window, and avoid having multiple tabs open in the same window.</li>
- 2. To apply, log into your existing account, or create an account if you do not yet have one.

You must include your full name, last 4 digits of your Social Security Number (SSN), your Applicant ID Number (if known), your online application confirmation number, and the exam title and number with your request. - 5. Below the confirmation number, a Pay Examination Fee button will appear for you to click to open the payment page.
- 6. A major credit card or a bank card associated with a bank account must be used when paying the application fee, and this fee will appear on your credit or bank card statement as "MTA NYCT Exam Fee." <u>Note</u>: Disputing the application fee could result in removal from this examination, and it might affect your ability to apply online for any future examinations.
- 7. You will be sent a confirmation email after you submit payment for the application fee (Save this email for future reference).

**IMPORTANT**: Your application submission confirms that you have read this Notice of Examination, including any dates and the requirements.

**Application Fee**: This fee is generally not refundable. Under special circumstances, you may be entitled to a refund. Please refer to the Department of Citywide Administrative Services ("DCAS") General Exam Regulation E.3.4 to determine if you are entitled to a refund. ## ADMISSION LETTER OR NOTICE OF PROPOSED DISQUALIFICATION

An Admission Letter or a Notice of Proposed Disqualification will be mailed to you at least 10 days before the first date of the practical skills test. If you do not receive an Admission Letter or Notice of Proposed Disqualification at least 4 days before this date, you **must** email a request for a duplicate Admission Letter/Notice of Proposed Disqualification to <a href="mailto:examsunit@nyct.com">examsunit@nyct.com</a>. A paper copy of the Admission Letter is your ticket for admission to the test.

Applicants **must** keep their mailing address **up to date**. Please refer to the "Correspondence" section below for instructions on how to update your address and other contact information.

#### THE TEST

You will be given a <u>competitive</u> practical skills test and a <u>qualifying</u> climbing assessment. The <u>competitive</u> practical skills test and the <u>qualifying</u> climbing assessment will be administered in a single session on the same day. A score of at least 70% is required to pass the <u>competitive</u> practical skills test and a score of 100% is required to pass the <u>qualifying</u> climbing assessment. Your score on the competitive practical skills test will be used to determine your place on the eligible list.

You will be assigned to a test date and location, and you cannot request that your scheduled test date or location be changed, unless you meet the conditions in the "Special Arrangements" section below.

Veterans' or Disabled Veterans' Credit will be granted only to eligible passing candidates who request that they be applied. Veterans' or Disabled Veterans' Credit should be requested at the time of application but **must** be requested before the date the eligible list is established. Claims for Veterans' or Disabled Veterans' Credit will <u>not</u> be made once the eligible list is established.

The <u>competitive</u> practical skills test may measure your ability to perform layout according to specifications on a drawing; use tools to perform structural work, including welding, burning, rigging, high-strength bolting and rivet removal on steel components of structures. During the <u>qualifying</u> climbing assessment, you will be required to safely climb a ladder that is approximately 30 feet in height, walk across an elevated platform and safely descend a staircase.

#### **TEST ADMINISTRATION GUIDELINES**

**Warning:** You are not permitted to enter the test site with cellular phones, smart watches, beepers, pagers, cameras, portable media players, or other electronic devices. Calculators are permitted; however, they must be hand-held, battery or solar powered, numeric only. Calculators with functions **other than** addition, subtraction, multiplication and division **are prohibited**. Electronic devices with an alphabetic keyboard or with word processing or data recording capabilities such as planners, organizers, etc. are prohibited. If you use any of these devices in the building at any time before, during or after the test, you may **not** receive your test results, your test score may be nullified, and your application fee will **not** be refunded.

**Social Distancing** and other safety protocols, **including the wearing of masks**, will be required during the administration of the test. Further details will be provided on your Admission Letter.

You may not have any other person, including children, present with you while you are being processed for or taking the test and no one may wait for you inside of the test site while you are taking the test.

Required Identification: You are required to bring one (1) form of valid (non-expired) signature and photo bearing identification to the test site. The name that was used to apply for the exam must match the first and last name on the photo ID. A list of acceptable identification documents is provided below. If you do not have an acceptable ID, you may be denied testing. Acceptable forms of identification (bring one) are as follows: State issued driver's license, State issued identification card, US Government issued Passport, US Government issued Military Identification Card, US Government issued Alien Registration Card, IDNYC, Employer ID with photo, or Student ID with photo.

**Leaving:** You must leave the test site once you finish the test. If you leave the test site after being fingerprinted but before finishing the test, you will not be permitted to re-enter. If you disregard this instruction and re-enter the test site, you may not receive your test results, your test score may be nullified, and your application fee will not be refunded.

## THE TEST RESULTS

If you meet the education and experience requirements and pass the <u>competitive</u> practical skills test and the <u>qualifying</u> climbing assessment, your name will be placed in final score order on an eligible list, and you will be given a list number. You will be notified by mail of your test results. If you meet all the requirements and conditions, you will be considered for appointment when your name is reached on the eligible list.

## ADDITIONAL INFORMATION

**Training:** You may be required to undergo a formalized training course during your probationary period. Failure to successfully complete the training course may result in termination.

**Probationary Period:** You will be required to complete a probationary period. If you do not successfully complete the probationary period, you may be terminated.

## **ADDITIONAL INFORMATION** (Continued)

Selective Certification for New York City Welder License (LWD): If you have a New York City welder license, a New York State Department of Transportation (NYSDOT) 3G and 4G welder certification, or an American Welding Society (AWS) D1.1 Certification, you may be considered for appointment to a position through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for a position that requires this certification. If you have qualifying experience, as listed below, follow the instructions given to you on the date of the practical skills test to indicate your interest in such selective certification. Your experience will be verified by MTA New York City Transit at the time of consideration for appointment.

If you are appointed to a position through Selective Certification based on having a welder <u>certification</u>, you must obtain a New York City welder <u>license</u> within twelve months of your date of appointment and it must be maintained for the duration of your employment. The above Selective Certification requirements may be met at any time during the duration of the list. If you meet this requirement at some future date, please submit a request by mail to the address in the correspondence section below. Please include the examination title and number, your social security number, and the Selective Certification you are requesting in your correspondence.

## SPECIAL ARRANGEMENTS

Special Test Accommodations: If you plan to request an alternate test date due to your religious observance or special testing accommodations due to disability, please follow the instructions included in the Special Circumstances Guide, which is accessible online at <a href="http://web.mta.info/nyct/hr/forms\_instructions.htm">http://web.mta.info/nyct/hr/forms\_instructions.htm</a> and will be attached to this Notice of Examination during the application period. An alternate test date due to religious observance must be requested no later than 15 days prior to the date on which practical skills testing is expected to begin. Special testing accommodations due to disability must be requested no later than 30 days prior to the date on which practical skills testing is expected to begin.

**Make-Up Tests:** You may apply for a make-up test if you cannot take the practical skills test as scheduled for any of the following reasons:

- 1. Compulsory attendance before a public body; or
- 2. On-the-job injury or illness caused by municipal employment where you are an officer or employee of the City; or
- 3. Absence from the test within one week after the death of a spouse, domestic partner, parent, sibling, child, or child of a domestic partner where you are an officer or employee of the City; or
- 4. Absence due to ordered military duty; or
- 5. A clear error for which MTA New York City Transit is responsible; or
- 6. A temporary disability, pregnancy-related, or child-birth related condition preventing you from taking the test
