#### JOB DESCRIPTION

**Plant and Equipment Maintainers (Electrical)** under supervision, inspect, test, alter, maintain and repair lighting and other electrical systems in MaBSTOA/New York City Transit buildings and facilities such as bus depots and repair shops; and perform other related work.

Some of the physical activities performed by Plant and Equipment Maintainers (Electrical) and environmental conditions they experience are: crouching while working in confined spaces, climbing ladders, platforms and scaffolds; working in dimly lit areas; using hand and power tools and equipment; and working outdoors in all weather conditions.

**Special Working Conditions:** Plant and Equipment Maintainers (Electrical) may be required to work various shifts including nights, Saturdays, Sundays and holidays.

(This brief description does not include all of the duties of this position.)

#### **SALARY AND BENEFITS**

The current minimum salary for Plant and Equipment Maintainer (Electrical) is \$35.86 per hour for a 40-hour work week increasing to \$42.01 per hour in the sixth year of service. These rates are subject to change. The benefits of this position include, but are not limited to, night and weekend salary differentials, paid holidays, vacation and sick leave, a comprehensive medical plan and a pension plan.

#### **HOW TO QUALIFY**

**Education and Experience Requirements:** By the **last day of the Application Period,** you must meet the following requirements:

- Four years of full-time paid experience as an electrician at the journey-level working from blueprints, schematics and technical drawings, installing, inspecting, troubleshooting, testing, overhauling, repairing and maintaining industrial and commercial electrical equipment and systems; or
- 2. Three years of full-time paid experience at the journey-level as describe in "1" above, plus graduation from a recognized trade school, vocational high school, or community college with a major sequence of courses in electronic technology, or electrical installations; or
- Three years of full-time satisfactory experience at the journey-level described in "1" above, plus two years of relevant full-time satisfactory helper experience as described in "1" above; or
- 4. Completion of a four-year full-time apprenticeship in the electrical trade recognized by New York State Department of Labor, the U.S. Department of Labor or any state apprenticeship council which is recognized by the U.S. Department of Labor.

If you have qualifying part-time experience, it will be credited on a prorated basis.

The vocational high school, technical school, or trade school must be approved by a State's Department of Education or a recognized accrediting organization. The college or university must be accredited by regional, national, professional or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education, and by the Council for Higher Education Accreditation (CHEA).

Foreign Education Fact Sheet (required only if you need credit for your foreign education for this examination): If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation, as well as instructions on how to submit this evaluation are listed in the Foreign Education Fact Sheet, which will be attached to this Notice of Examination during the application period. When you contact the evaluation service, ask for a "document-by-document" (general) evaluation of your foreign education. Your foreign education evaluation must be submitted directly to NYC Transit's Examinations Unit by the service completing the evaluation. Foreign education evaluations received directly from applicants will not be accepted. **Note:** If you have earned a higher-level degree in the United States that supersedes the level and type of education required to meet the qualification requirements, you do not need to submit a foreign education evaluation. However, you must indicate that you have completed the higher-level degree in the United States; proof of acceptance into an academic program or school is not sufficient to determine satisfactory equivalency.

#### THE TEST

You will be given a <u>competitive</u> practical skills test. A score of at least 70% is required to pass this test. Your score on this test will be used to determine your place on the eligible list.

You will be scheduled to take the test as indicated in the above "Test Date" box. You will be assigned to a test date and location, and you cannot request that your scheduled test date or location be changed, unless you meet the conditions in the "Special Test Accommodations" subsection below.

The practical skills test may measure your knowledge, skills and abilities in the following and other related areas:

- **Lighting and other Electrical Systems –** Knowledge of the installation, testing, maintenance and repair of lighting and other electrical systems utilizing safe work practices.
  - o Example: Repairing a ballast that is flickering.
- **Schematics** The ability to read electrical schematics. This includes the ability to read and understand schematic symbols.
  - o Example: Using a circuit schematic to trace the circuit you are working on.
- **Meter Usage** The ability to utilize an electrical meter to troubleshoot a circuit, component and/or piece of equipment utilizing safe work practices.
  - o Example: Using a multimeter to determine if a fuse is blown.
- Mechanical Aptitude The ability to understand and apply mechanical concepts and principles to solve problems.
  - Example: Understanding that gas-powered tool needs fuel when the fuel gauge is near empty.
- **Tool Usage** Knowledge of hand tools, power tools and/or multi-purpose tools and their proper usage in the electrical trade utilizing safe work practices.
  - o Example: Using a screwdriver safely to remove a screw from an electrical panel.

#### **HOW TO OBTAIN AN APPLICATION**

During the application period, you may apply online for this examination (see the Online Applications sub-section below). If you believe you have a special circumstance (e.g., a disability, military duty) that prevents you from applying as instructed below, please refer to the Special Circumstances Guide referenced in the "Special Test Accommodations" subsection below.

#### **HOW TO SUBMIT AN APPLICATION**

You must submit an application during the application period, and applications will <u>not</u> be accepted in person. Applicants who apply online and wish to request a Fee Waiver <u>must</u> only complete the Online Applications Steps 1 through 4 below.

#### **Online Applications:**

- 5. Below the confirmation number, a Pay Examination Fee button will appear for you to click to open the payment page.
- 6. A major credit card or a bank card associated with a bank account must be used when paying the application fee, and this fee will appear on your credit or bank card statement as "MTA NYCT Exam Fee." <u>Note</u>: Disputing the application fee could result in removal from this examination, and it might affect your ability to apply online for any future examinations.
- 7. You will be sent a confirmation email after you submit payment for the application fee (Save this email for future reference).

**Application Fee**: This fee is generally not refundable. Under special circumstances, you may be entitled to a refund. An alternate FF test as scheduled for any of the following reasons:

- 1. Compulsory attendance before a public body; or
- 2. On-the-job injury or illness caused by municipal employment where you are an officer or employee of the City; or
- 3. Absence from the test within one week after the death of a spouse, domestic partner, parent, parent-in-law, sibling, child, or child of a domestic partner where you are an officer or employee of the City; or
- 4. Absence due to ordered military duty; or
- 5. A clear error for which MTA New York City Transit is responsible; or
- 6. A temporary disability; or

7. Pregnancy, childbirth or a related medical condition.

#### CORRESPONDENCE

Change of Contact Information: It is critical that you keep your contact information (i.e., telephone number, mailing address and/or email address) current with MTA New York City Transit. You may miss important information about your exam(s) or consideration for appointment or promotion, including important information that may require a response from you by a specified deadline, if we do not have your correct contact information. #### **TEST SITE REQUIREMENTS**

Admission Letter or Notice of Proposed Disqualification: An Admission Letter or a Notice of Proposed Disqualification will be mailed to you at least 10 days before the first date of the practical skills test. If you do not receive an Admission Letter or Notice of Proposed Disqualification at least 4 days before this date, you must email a request for a duplicate Admission Letter/Notice of Proposed Disqualification to <a href="mailto:examsunit@nyct.com">examsunit@nyct.com</a>. A paper copy of the Admission Letter is your ticket for admission to the test.

Applicants **must** keep their mailing address **up to date**. Please refer to the "Correspondence" section above for instructions on how to update your address and other contact information.

**Warning:** You are not permitted to enter the test site with cellular phones, smart watches, beepers, pagers, cameras, portable media players, or other electronic devices. Calculators are permitted; however, they must be hand-held, battery or solar powered, numeric only. Calculators with functions **other than** addition, subtraction, multiplication and division **are prohibited**. Electronic devices with an alphabetic keyboard or with word processing or data recording capabilities such as planners, organizers, etc. are prohibited. If you use any of these devices in the building at any time before, during or after the test, you may **not** receive your test results, your test score may be nullified, and your application fee will **not** be refunded.

You may not have any other person, including children, present with you while you are being processed for or taking the test and no one may wait for you inside of the test site while you are taking the test.

Required Identification: You are required to bring one (1) form of valid (non-expired) signature and photo bearing identification to the test site. The name that was used to apply for the exam must match the first and last name on the photo ID. A list of acceptable identification documents is provided below. If you do not have an acceptable ID, you may be denied testing. Acceptable forms of identification (bring one) are as follows: State issued driver's license, State issued identification card, US Government issued Passport, US Government issued Military Identification Card, US Government issued Alien Registration Card, IDNYC, Employer ID with photo, or Student ID with photo.

**Leaving:** You must leave the test site once you finish the test. If you leave the test site after being fingerprinted but before finishing the test, you will not be permitted to re-enter. If you disregard this instruction and re-enter the test site, you may not receive your test results, your test score may be nullified, and your application fee will not be refunded.

#### THE TEST RESULTS

If you meet the education and experience requirements and pass the competitive practical skills test, your name will be placed in final score order on an eligible list and you will be given a list number. You will be notified by mail of your test results. If you meet all the requirements and conditions, you will be considered for appointment when your name is reached on the eligible list.

#### REQUIREMENTS TO BE APPOINTED

**Driver License Requirement:** At the time of appointment, you must possess either:

- 1. A Class A or Class B Commercial Driver License (CDL) valid in the State of New York with no disqualifying restrictions that would preclude the performance of the duties of this title; or
- 2. A Motor Vehicle Driver License valid in the State of New York and a Learner Permit for a Class B CDL valid in the State of New York with no disqualifying restrictions.

If you qualify under "2" above, your appointment will be subject to the receipt of a Class B CDL valid in the State of New York with no disqualifying restrictions within 120 days of appointment, or your employment will be terminated. If you have serious moving violations, a license suspension or an accident record, you may be disqualified.

The Class A or Class B Commercial Driver License (CDL) with no disqualifying restrictions must be maintained for the duration of your employment in the title. Such license and/or Learner Permit must not include any restrictions which would preclude the performance of Plant and Equipment Maintainer (Electrical) work.

Commercial Motor Vehicle Driving Experience in the Military or New York National Guard: If you are an active member or former member (discharged in the past year) of the military or New York National Guard and have experience driving a Commercial Motor Vehicle in the military or New York National Guard, you may be eligible for a waiver of the New York State commercial driving skills test through the New York State Department of Motor Vehicles. If you believe that you may be eligible for this waiver, you must apply for the waiver through the New York State Department of Motor Vehicles.

**Drug Screening Requirement:** You must pass a drug screening in order to be appointed, and if appointed, you will be subject to random drug and alcohol tests for the duration of your employment.

Additionally, if you have tested positive on a drug or alcohol test or had a refusal to test during preemployment or while employed by a Federal DOT-regulated employer during the applicable period, you must have completed the Substance Abuse Professional (SAP) evaluation, referral and education/treatment process required by federal law in order to be appointed to this safety-sensitive position.

**Residency:** New York City residency is not required for this position.

**English Requirement:** You must be able to understand and be understood in English to perform the duties and responsibilities of the position.

**Proof of Identity:** Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with MaBSTOA.

#### ADDITIONAL INFORMATION

**Probationary Period:** You will be required to complete a probationary period. If you do not successfully complete the probationary period, you may be terminated.

**Training:** You may be required to undergo a formalized training course during your probationary period. Failure to successfully complete the training course may result in termination.

**Promotion Examination:** A promotion examination for this title is being held for Plant and Equipment Maintainer (Electrical) employees. The names appearing on the promotion list will be considered first in filling vacancies.

#### PENALTY FOR MISREPRESENTATION

Any intentional misrepresentation on the application or examination may result in disqualification, even after appointment, and may result in criminal prosecution.
