Practical Skills Testing is expected to begin on Monday, September 16, 2024

JOB DESCRIPTION

Signal Maintainers, under supervision, maintain, install, inspect, test, alter and repair MTA New York City Transit's railroad signal systems on the road and in the shop. They maintain, service and repair various types of railroad signal equipment, including all-electric, electro-pneumatic, optical, all-relay, and mechanical interlocking machines, centralized traffic control machines, electronic code systems, train identity systems, microprocessors, switch machines, automatic train stops, color light and semaphore signals, electronic train control and monitor systems, and related power and control equipment. They keep records; drive a motor vehicle; and perform related work.

Some of the physical activities performed by Signal Maintainers and environmental conditions they experience are: working on or near train tracks where live high voltage equipment is present; climbing and descending ladders and stairways; walking along trackways in dimly lit areas where tripping hazards may be present; when in work areas, being alert to warning whistles and the sound of oncoming trains; working outdoors in all weather conditions; carrying tools and equipment; and operating heavy machinery.

Special Working Conditions: Signal Maintainers may be required to work various shifts, including nights, Saturdays, Sundays and holidays.

(This brief description does not include all of the duties of this position.)

SALARY

The current minimum salary for Signal Maintainer is \$42.82 per hour for a 40-hour work week. This rate is subject to change.

ELIGIBILITY TO TAKE EXAMINATION

This examination is open to each employee of MTA New York City Transit who **on the first date of the practical skills test**:

- Is permanently (not provisionally) employed in or appears on a Preferred List (see note, below)
 for the title of Transit Electrical Helper (working in Signal Maintenance Group of the Division of
 Maintenance of Way) and has been permanently employed in such title for not less than one
 year immediately prior to the first date of the practical skills test; or
- 2. Is or has been employed in the non-competitive title of Transit Electrical Apprentice and has satisfactorily completed the 3-year Transit Electrical Apprentice program in Signal Maintenance and is employed in the Division of Maintenance of Way; and
- 3. Is not otherwise ineligible.

The admission of employees who are employed in the non-competitive title of Transit Electrical Apprentice in the Division of Maintenance of Way is pursuant to Section §52(14) of the New York Civil Service Law.

(Note: A "Preferred List" is a civil service list which is only for certain former permanent incumbents of the eligible title who have rehiring rights.)

This examination is also open to employees who were appointed to an eligible title pursuant to New York State Civil Service Law, section 55-a, and who meet all other eligibility requirements.

You are responsible for determining whether you meet the eligibility requirements for this examination prior to submitting the Application. If you do not know if you are eligible, check with **your department's Human Resources representative**. You may be given the test before we verify your eligibility. If you are marked "Not Eligible," your application fee will **not** be refunded, and you will **not** receive a score.

This examination is **not** open to employees of MaBSTOA or MTA Bus Company, or to employees of MTA agencies other than MTA New York City Transit.

THE TEST

You will be given a competitive practical skills test. A score of at least 65% is required to pass this test.

You will be scheduled to take the test on a date indicated in the above "Test Date" box. You will be assigned to a test date and location, and you cannot request that your scheduled test date or location be changed, unless you meet the conditions in the "Special Test Accommodations" subsection below.

Your score on this <u>competitive</u> practical skills test will determine 85% of your final score. Your seniority will determine the remaining 15%. You must pass the <u>competitive</u> practical skills test to have your seniority credited. Your seniority score will be 70 plus ½ point for each three months of completed continuous service with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services, in permanent competitive class titles or non-competitive class titles. Your service will be credited through the first date of the <u>competitive</u> practical skills test, up to a maximum of 15 years. Time served prior to a break in service of more than one year will not be credited.

Veterans' or Disabled Veterans' Credit will be granted only to eligible passing candidates who request that they be applied. Veterans' or Disabled Veterans' Credit should be requested at the time of application but **must** be requested before the date the eligible list is established. Claims for Veterans' or Disabled Veterans' Credit cannot be made once the eligible list is established.

The practical skills test may measure your knowledge, skills and abilities in the following and other related areas:

- **Electrical Equipment**: Knowledge of electrical devices and principles; ability to install, test, maintain, and repair electrical systems and equipment utilizing safe work practices
 - o Example: Locating a defect using point-to-point troubleshooting

- **Electronic Equipment:** Knowledge of electronic devices and principles; ability to install, test, maintain, and repair electronic systems and equipment utilizing safe work practices
 - o Example: Using a computer application to program electronic equipment
- Electro-Mechanical Equipment: Knowledge of electro-mechanical devices and principles; ability to install, test, maintain, and repair electro-mechanical systems and equipment utilizing safe work practices
 - o Example: Repairing a piece of equipment that has stopped working
- **Tool Usage:** Knowledge of hand tools, power tools and/or multi-purpose tools and their proper safe usage in the electrical, electronic and electro-mechanical trade
 - o Example: Using a screwdriver to remove a screw
- Schematics: Reading and interpreting technical drawings
 - o Example: Using a circuit schematic to trace the circuit you are working on

HOW TO SUBMIT AN APPLICATION

If you believe you meet the requirements in the "Eligibility to Take Examination" section, you may submit an application during the application period. If you believe you have a special circumstance (e.g., a disability, military duty) that prevents you from applying as instructed below, please refer to the Special Circumstances Guide referenced in the "Special Test Accommodations" subsection below. Applications will **not** be accepted in person.

Online Applications:

- 1. If you are an active MTA employee, apply using the MTA Business Service Center (BSC) employee portal at www.mymta.info by the last day of the application period (non-active MTA employees and applicants requesting a fee waiver must email us by the last day of the application period at examsunit@nyct.com for application instructions). Note: The application system may not function properly with mobile devices or tablets. For best results when applying, please use the latest version of Microsoft Edge, open a new window, and avoid having multiple tabs open in the same window.
- 2. Once you have logged in, click on the My Job Search ribbon and then click on Exams (non-Railroad).
- 3. Follow the steps to submit an application.
- 4. Active MTA employees must pay the application fee via payroll deduction.
- 5. A confirmation number will appear on the same page after submitting your application and authorizing a payroll deduction (Save this number for future reference).

IMPORTANT: Your application submission confirms that you have read this Notice of Examination, including any dates and the requirements.

Application Fee: This fee is generally not refundable. Under special circumstances, you may be entitled to a refund. Please refer to the Department of Citywide Administrative Services ("DCAS") General Exam Regulation E.3.4 to determine if you are entitled to a refund. If you submit an application for this promotion examination and you also submit an application for the open competitive examination for Signal Maintainer, Exam No. 4621, you will only be permitted to take the test(s) for this title one time.

Late Applications: Refer to the "Correspondence" section below to contact the Examinations Unit to determine the procedure for submitting a late application if you meet one of the following conditions:

- 1. You are absent from work for at least one-half of the application period and are unable to apply for reasons such as vacation, sick leave or military duty; or
- 2. You become eligible after the above application period, but before the first test date.

Special Test Accommodations: If you plan to request an alternate test date due to your religious observance or special testing accommodations due to disability, please follow the instructions included in the Special Circumstances Guide, which is accessible online at http://web.mta.info/nyct/hr/forms_instructions.htm and will be attached to this Notice of Examination during the application period. An alternate test date due to religious observance must be requested no later than 15 days prior to the date on which practical skills testing is expected to begin. Special testing accommodations due to disability must be requested no later than 30 days prior to the date on which practical skills testing is expected to begin.

Make-Up Tests: You may apply for a make-up test if you cannot take the practical skills test as scheduled for any of the following reasons:

- 1. Compulsory attendance before a public body; or
- 2. On-the-job injury or illness caused by municipal employment where you are an officer or employee of the City; or
- 3. Absence from the test within one week after the death of a spouse, domestic partner, parent, parent-in-law, sibling, child, or child of a domestic partner where you are an officer or employee of the City; or
- 4. Absence due to ordered military duty; or
- 5. A clear error for which MTA New York City Transit is responsible; or
- 6. A temporary disability; or
- 7. Pregnancy, childbirth or a related medical condition.

To request a make-up test, submit your request with documentation of the special circumstances that caused you to miss your test (as attachments) by email to examsmakeups@nyct.com or by mail to the address in the "Correspondence" section below as soon as possible.

CORRESPONDENCE

Change of Contact Information: It is critical that you keep your contact information (i.e., telephone number, mailing address and/or email address) current with MTA New York City Transit. You may miss important information about your exam(s) or consideration for appointment or promotion, including important information that may require a response from you by a specified deadline, if we do not have your correct contact information.

Your request must include your full name, exam title(s), exam number(s) and your old and new telephone numbers, mailing and/or email address. TEST SITE REQUIREMENTS

An Admission Letter will be mailed to you about 10 days before the first date of the practical skills test. If you do not receive an Admission Letter at least 4 days before this date, you must email a request for a duplicate Admission Letter to examsunit@nyct.com. A paper copy of the Admission Letter is your ticket for admission to the test.

Applicants **must** keep their mailing address **up to date**. Please refer to the "Correspondence" section above for instructions on how to update your address and other contact information.

Warning: You are not permitted to enter the test site with cellular phones, smart watches, beepers, pagers, cameras, portable media players, or other electronic devices. Calculators are permitted; however, they must be hand-held, battery or solar powered, numeric only. Calculators with functions **otherthan** addition, subtraction, multiplication and division **are prohibited**. Electronic devices with an alphabetic keyboard or with word processing or data recording capabilities such as planners, organizers, etc. are prohibited. If you use any of these devices in the building at any time before, during or after the test, you may **not** receive your test results, your test score may be nullified, and your application fee will **not** be refunded.

You are also not permitted to use on site any medical assistive devices, including those that give notification or alerts, or that vibrate, without the prior express written authorization of MTA New York City Transit. You can contact MTA New York City Transit by email at: examsmakeups@nyct.com.

You may not have any other person, including children, present with you while you are being processed for or taking the test and no one may wait for you inside of the test site while you are taking the test.

Leaving: You must leave the test site once you finish the test. If you leave the test site after being fingerprinted but before finishing the test, you will not be permitted to re-enter. If you disregard this instruction and re-enter the test site, you may not receive your test results, your test score may be nullified, and your application fee will not be refunded.

Proof of Identity: You must present your MTA New York City Transit employee ID when you arrive to take the test.

THE TEST RESULTS

If you pass the competitive practical skills test and are marked eligible, your name will be placed in final score order on an eligible list and you will be given a list number. You will be notified by mail of your test results. If you meet all requirements and conditions, you will be considered for promotion when your name is reached on the eligible list.

REQUIREMENTS TO BE PROMOTED

From the competitive title of Transit Electrical Helper: At the time of promotion, you must have completed your probationary period in the eligible title of Transit Electrical Helper (working in the Signal Maintenance Group of the Division of Maintenance of Way) and you must be permanently employed in that title or your name must appear on a Preferred List for that eligible title. Additionally, you must have served permanently in the eligible title of Transit Electrical Helper for at least one year. Time served prior to a break in service of more than one year will not be credited.

From the non-competitive title of Transit Electrical Apprentice: At the time of promotion, you must be employed or have been employed in the title of Transit Electrical Apprentice in the Division of Maintenance of Way.

Driver License Requirement: At the time of promotion, you must have a Motor Vehicle Driver License valid in the State of New York with no disqualifying restrictions that would preclude the performance of the duties of this title. If you have serious moving violations, a license suspension or an accident record you may be disqualified. This license must be maintained for the duration of your employment in the title.

Medical Requirement: Medical guidelines have been established for the position of Signal Maintainer. Candidates will be examined to determine whether they can perform the essential functions of the position. Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable such person to perform the essential functions of the job.

Drug Screening Requirement: You must pass a drug screening in order to be promoted, and if promoted, you will be subject to random drug and alcohol tests for the duration of your employment. Additionally, if you have tested positive on a drug or alcohol test or had a refusal to test during preemployment or while employed by a Federal DOT-regulated employer during the applicable period, you must have completed the Substance Abuse Professional (SAP) evaluation, referral and education/treatment process required by federal law in order to be promoted to this safety-sensitive position.

ADDITIONAL INFORMATION

Training: You may be required to undergo a formalized training course during your probationary period. Those probationary employees from the permanent title of Transit Electrical Helper who do not successfully complete this training course will be returned to their previous title. Those probationary employees from the title of Transit Electrical Apprentice who do not successfully complete this training course may be returned to their permanent title if they have any or may be terminated from the title of Signal Maintainer.

Probationary Period: You will be required to complete a probationary period. If you do not successfully complete the probationary period, you may be terminated or returned to your previously held permanent title.

PENALTY FOR MISREPRESENTATION

Any intentional misrepresentation on the application or examination may result in disqualification, even after promotion, and may result in criminal prosecution.
