



## **CONDITIONAL NOTICE OF REDEMPTION**

### **TRIBOROUGH BRIDGE AND TUNNEL AUTHORITY GENERAL REVENUE BONDS**

**[Series, maturity, principal amount to be redeemed, interest rate, redemption date, redemption price, and CUSIP # as derived from Schedule I hereto]**

NOTICE IS HEREBY GIVEN to the registered holders of the Triborough Bridge and Tunnel Authority's General Revenue Bonds described in Schedule I attached hereto (the "Refunded Bonds") that such Refunded Bonds have been called for redemption prior to maturity on the dates set forth on Schedule I (the "Redemption Date"), at the redemption prices specified therein, plus accrued interest up to, but not including, the Redemption Date. Interest on all Refunded Bonds will cease to accrue on their respective Redemption Dates. Redemption of the Refunded Bonds on such date of redemption is subject to and conditioned upon receipt by the Trustee of money sufficient to pay the redemption price of the Refunded Bonds to be redeemed on their respective Redemption Dates.

Withholding of a portion of gross payments made within the United States may be required under section 3406 of the Internal Revenue Code of 1986, unless the Trustee has the correct taxpayer identification number (social security or employer identification number) or exemption certificate of the payee. Owners should furnish a properly completed Form W-9 or exemption certificate or equivalent when presenting their Refunded Bonds for payment.
