DESCRIPTION: This Contract is being solicited by MTA Construction & Development Company (“MTA C&D”) acting on behalf of the Metropolitan Transportation Authority (“MTA” or “Contracting Party”) for the C40299 - Replacement of HVAC, Boiler, Air Curtain, and Fire Alarm, Installation of BMS, and Rehabilitation of Depot and Parking Lot at 3 Bus Depots in Manhattan, Brooklyn, and Staten Island This is an A+B bidding contract.

On October 3, 2025, the United States Department of Transportation (“U.S. DOT”) issued an Interim Final Rule (“IFR”) implementing changes to its Disadvantaged Business Enterprise (“DBE”) Program regulations, which are applicable to all contracts that include U.S. DOT federal financial assistance, which includes the Contract that may be entered as a result of this procurement. The IFR bears an immediate effective date as of its publication and states that DBE programs of U.S. DOT federal financial recipients (which includes the MTA) must update their terms to comply with the revised regulations. In accordance with the IFR, Unified Certification Programs (“UCPs”) must then, on the basis of the revised terms, reevaluate any firm that has applied for DBE status, and, based on the re-assessment of its overall DBE goal, set any contract-specific goals. As this has not yet occurred, the goal for this Contract is 0%.
