The PMC shall provide Construction Support Services and Closeout Services on behalf of the MTA C&D for the following four (4) projects (the “Projects”) as set forth below:

2. TN-9I – Water Based Pier Rehabilitation Prototype at the Throgs Neck Bridge
3. TNM-405 – Replacement of Sidewalks and Curbs at the Throgs Neck Service - Building (MTA Small Business Mentoring Program)
